PROOF OF AGE TO BE SUBMITTED ONLY WHEN LEGAL AGE IS IN DOUBT

- 1. An original or certified copy of a record of birth
- 2. An original or certified copy of a baptismal record
- 3. A passport
- 4. A life insurance policy
- 5. An employment certificate
- 6. A school record
- 7. An immigration record
- 8. A naturalization record
- 9. A court record
