Evidence of Where the Parties Reside and Intend to Continue to Reside (G. L. c.207 ss. 11, 12)

"No marriage shall be contracted in this commonwealth by a party residing and intending to continue to reside in another jurisdiction if such marriage would be void if contracted in such other jurisdiction, **and every marriage contracted in this commonwealth in violation hereof shall be null and void.**" G. L. c.207 s.11

"Before issuing a license to marry [to] a person who resides and intends to continue to reside in another state, the officer having authority to issue the license shall satisfy himself, by requiring affidavits or otherwise, that such person is not prohibited from intermarrying by the laws of the jurisdiction where he or she resides." G. L. c.207 s.12
